

GENERAL APPROPRIATION RESOLUTION as amended

RESOLUTION FOR ADOPTION  
BY THE BOARD OF EDUCATION OF  
INTERNATIONAL ACADEMY OF FLINT

RESOLVED, that this resolution shall be the general appropriations of International Academy of Flint for the fiscal year 2006/2007 as amended: A resolution to make appropriations; to provide for the expenditure of the appropriations; and to provide for the disposition of all income received by International Academy of Flint.

BE IT FURTHER RESOLVED, that the total revenues and unappropriated fund balance estimated to be available for appropriations in the general fund of International Academy of Flint for fiscal year 2006/2007 is as follows:

Note: The expenditures are listed in the amount of detail which represents the level at which the board of education intends to control expenditures. The level of control is at the functional level and the amounts listed above are the appropriate amount of detail.

FURTHER RESOLVED, that no board of education member or employee of the International Academy of Flint shall expend any funds or obligate the expenditure of any funds except pursuant to appropriations made by the board of education and in keeping with the budgetary policy statement hitherto made by the board. However, the Chief Administrative Officer may expend funds in excess of the appropriations provided that the excess does not exceed 10% of the total amount originally appropriated for any function level and provided that the total appropriated in the aggregate is not exceeded. Changes that exceed 10% in the amount appropriated by the board shall require approval by the board.

BE IT FURTHER RESOLVED, that the Chief Administrative Officer is hereby charged with general supervision and administration of the execution of the budget adopted by the board.

This appropriation is to take effect on July 1, 2006.
