FURTHER RESOLVED, that no board of education member or employee of the International Academy of Flint shall expend any funds or obligate the expenditure of any funds except pursuant to appropriations made by the board of education and in keeping with the budgetary policy statement hitherto made by the board. However, the Chief Administrative Officer may expend funds in excess of the appropriations provided that the excess does not exceed 10% of the total amount originally appropriated for any function level and provided that the total appropriated in the aggregate is not exceeded. Changes that exceed 10% in the amount appropriated by the board shall require approval by the board.

BE IT FURTHER RESOLVED, that the Chief Administrative Officer is hereby charged with general supervision and administration of the execution of the budget adopted by the board.

This appropriation is to take effect on July 1, 2006.
